**WE HAVE IMPLEMENTED NUMEROUS PROTOCOLS TO KEEP EMPLOYEES AND VISITORS SAFE WHILE AT THE DENVER DESIGN DISTRICT®**

- ◆ Access is limited to the main DDC entrance to monitor traffic at the main desk check-in point.
- ◆ For notification purposes if necessary, all visitors must check-in with the receptionist to provide name, phone number, and the showrooms to be visited by all members of the party. Alternatively, a business card can be provided in addition to showrooms visited.
- ◆ Fully vaccinated people are not required to wear a mask but it is highly recommended. Individual showrooms may still require masks.
- ◆ Unvaccinated people are required to wear a mask for entry to the building.
- ◆ Hand-sanitizing stations installed throughout the DDC common areas.
- ◆ Social distancing of 6 ft. or more is requested.
- ◆ We reserve the right to symptom monitor and request proof of vaccination.
- ◆ Please do not enter the buildings if you have had a fever in the last 5 days, or if you are exhibiting any cold/flu-like symptoms.

### Cleaning and Sanitizing:

- ◆ Daily cleaning and sanitizing high-touch areas and surfaces in the DDC common areas including showroom door handles and restrooms.

### Showrooms:

- ◆ Showrooms are expected to monitor and manage the activity in the showrooms for compliance with safe distancing, prescribed occupancy restrictions, use of PPE, and cleaning protocols.

### Responsibilities and Notifications:

- ◆ In the event of a confirmed COVID-19 case or exposure anywhere in the showroom, the showroom is expressly responsible to:
  - If the person is unvaccinated -
    - Quarantine the employee(s)
    - Conduct a full COVID clean of the showroom
    - Notify building management and all visitors who were in the showroom during the time in question
    - Do not return to the Denver Design District until cleared per current CDC guidelines
  - If the person is vaccinated (breakthrough case) -
    - The employee(s) should isolate for 5 days
    - Conduct a full COVID clean of the showroom
    - Notify building management
    - Do not return to the Denver Design District until cleared per current CDC guidelines.

### **Visitors:**

- ◆ In the event of a confirmed COVID-19 case or exposure, visitors are expressly responsible to:
  - If the person is unvaccinated -
    - Quarantine per CDC guidelines
    - Notify building management and all showrooms visited during the time in question
    - Do not return to the Denver Design District until cleared per current CDC guidelines
  - If the person is vaccinated (breakthrough case) -
    - Isolate for 5 days
    - Notify building management
    - Do not return to the Denver Design District until cleared per current CDC guidelines.
